DECEMBER 2018 Recent Professional & Community Accomplishments

Congratulations to Michael Hackman (Tax Law), Andrew L. Shapiro (Personal Injury Litigation), Sue M. Bendavid (Employment Law), David Gurnick (Franchise Law), Kira S. Masteller (Trusts & Estates), and Lynn Soodik (Family Law) – all named Best Lawyers in America 2019. Mike is a State Bar of California Certified Specialist in Tax Law, and David is a Certified Specialist in Franchise and Distribution Law. David has been named to this list each consecutive year since 2008.

Samuel C. Wolf and **David Gurnick** represent a franchisor and its executive officers, defending claims brought by employees of a franchised location. Sam and David persuaded a court to dismiss all claims against the franchisor's individual executives and obtained their dismissal from the lawsuit. Additionally, they persuaded the opposing lawyer to voluntarily dismiss some claims against the franchisor, and persuaded the court to eliminate various other claims. The case has been narrowed substantially.

Veronica R. Woods successfully submitted a judgment of dissolution being entered by the end of this year taking advantage of the taxation effects of deductibility to our client the payor spouse. This law is significant in that it was enacted this year.

Tal Grinblat worked with a client to negotiate changes to a reality television show featuring our client. Because of Tal's efforts, the episode that aired recently omitted certain aspects our client found objectionable. Kevin E. Rex and Taylor M. Vernon worked closely with local counsel in several states to close a deal involving a private equity firm's purchase of three companies. affiliated Several employment agreements with key personnel, and various real estate issues with multiple affiliates, were all resolved. Peter L. Ente worked with the clients and their accountants regarding numerous tax implications, while local counsel assisted with state issues. Kevin spearheaded intense negotiations of the \$100 million stock sale over several months. The complex transaction included other incentives for the owners who originally pulled the deal off the table just prior to the original closing date, before finally coming to terms with the buyer and closing the deal.

Vanessa Soto Nellis (Certified Family Law Specialist) worked with a client to complete her dissolution of marriage matter, which had been pending for four years. With Vanessa's assistance, the parties were able to finally resolve their financial issues, divide property equitably, execute a Judgment of Dissolution and move on with their lives.

Paul C. Bauducco obtained a favorable settlement from a vendor who breached a contract to sell scrap metal to our client. The vendor agreed to the settlement shortly after Paul filed a lawsuit on behalf of our client. The settlement saves all parties time and expense of going to trial.

Tal Grinblat and **Katherine L. Wallman** filed a number of Letters of Protest in the Trademark Office alerting the Examining Attorney of our clients' trademark rights, with favorable results. A Letter of Protest is an efficient, yet infrequently used mechanism to block a confusingly similar trademark application without the cost and expense of opposing the application.

Kevin E. Rex and John B. Marshall worked closely with a client to purchase a commercial property, adjacent to various other parcels the client currently owns. The acquisition of this corner property gives our client the ability to redevelop a very valuable tract of real property in Los Angeles.

Nicholas Kanter and Tal Burnovski Yeyni successfully challenged claims filed against our client. Nick and Tal filed a demurrer in response to discrimination and harassment allegations made by the company's former employee. The Court sustained the demurrer as to four out of five causes of action, requiring the plaintiff to amend her complaint.

Veronica R. Woods finalized a dissolution that has been going on for over the statutory time period of five years in family law, resulting in an extension of time negating the mandatory dismissal. The multiple day trial ended in an equitable resolution of our client receiving his business franchise interest and real property.

Barry Kurtz and **David Gurnick** worked with a longtime franchisee to negotiate an early exit from the franchise system. Uncovering an obscure but substantive exemption violation by the franchisor provided a basis to seek and negotiate the exit. In a separate matter, Barry, David and **Katherine L. Wallman** provided an analysis of a franchisor's current form of franchise agreement, to an association of franchisees.

We are pleased to welcome **Daniella Rubin** to our Employment Practice Group as an Associate Attorney. Daniella graduated *cum laude* from Loyola Law School in May and was selected as a member of the *Order of the Coif*. Daniella began working with our firm as a Law Clerk in September, and has just been sworn in to the State Bar of California. Before joining Lewitt Hackman, Daniella served as an extern to the Honorable Otis D. Wright in U.S. District Court, Central District of California, and as Law Clerk for litigation departments in the Los Angeles area. Kevin E. Rex and Taylor M. Vernon worked with a franchisor and his investment banker to sell the franchise system to a private equity group for a purchase price in excess of \$50 million. The transaction involved more than 200 units across the country. As part of the deal, our client agreed to maintain a minority position in the company. Barry Kurtz (Certified Specialist in Franchise and Distribution Law) handled the franchise issues arising from the transaction and continues to represent the franchisor. Peter L. Ente structured the transaction and worked with the accountants on the various tax issues involved.

David B. Bobrosky of our Personal Injury Practice Group favorably resolved a client's case against a national grocery store chain. The client was burned by soup that splattered on her hand when she was filling her container. The specific location had closed since the incident, but Dave was able to settle the case without the need of litigation.

Tal Grinblat represented a client in negotiating a settlement of a business dispute that was pending in Alabama. The opposing side initially requested a six figure settlement to resolve the matter. Tal's efforts led to a favorable resolution for our client.

David Gurnick spoke on litigating the elements that make a business relationship a franchise at the American Bar Association's annual *Forum on Franchising*, which was held in Nashville, Tennessee in October.
