Some Recent Professional and Community Activities of Our Lawyers:

- Sue Bendavid and Nicole Kamm represented a corporate client with a substantial wage and hour/wrongful termination claim. After investigation, witness interviews, and depositions, Nicole and Sue obtained a settlement of less than one percent (1%) of what the ex-employee was demanding.
- Usually it is employees who sue under company's sex-harassment policies. But a client of the firm has sued two ex-employees for various misconduct, including violating the company's sex harassment policy by having an affair with each other. Steve Mihalovits and David Gurnick won a motion in court, requiring one of the ex-employees to answer deposition questions about details of their relationship.
- John B. Marshall and Kevin E. Rex assisted in a successful defense to a challenge of a sale of a large health care district's assets. The litigation consumed a full week of trial before the Bankruptcy Court. John was a significant witness at the trial as well as part of the defense team.
- **Barry T. Harlan** and **Vanessa Soto Nellis** defeated an ex-spouse's discovery motion in a financial dispute involving a claim of past due support payments. In a separate, marriage dissolution case, Barry and Vanessa won an award of attorney fees for a client, against the client's spouse.
- Kevin E. Rex assisted a business seller in settling the buyer's claims for breach of representations and warranties. Kevin negotiated a full release of all past, present and future breach of contract claims that the buyer could bring against the firm's client.
- Keith T. Zimmet guided a client in the use of an interest rate swap agreement with the client's lender, which effectively converted a variable loan into a fixed rate loan. In another matter, Keith assisted a client in the financing of several real estate transactions.





- Andrew L. Shapiro, Thomas Cecil, and David B. Bobrosky successfully recovered \$250,000 for a client hurt in an automobile accident. She had protected herself with her own Underinsured Motorist Insurance Policy, which allowed her to recover full compensation for her injuries, despite the negligent driver's lack of insurance. The matter confirmed our firm's long-standing policy of recommending to our clients that they carry the maximum amount of Uninsured/Underinsured Motorist protection.
- Keith T. Zimmet negotiated a restructuring of a client's asset based line of credit. The client does a tremendous amount of business in Asia, and therefore the transaction involved, among other lines of credit, letters of credit to be used in international transactions.
- Kevin E. Rex assisted the sole shareholder of a company in completing the sale of a minority interest to a longtime employee, and negotiating a favorable shareholder agreement with the new minority shareholder.
