# Recent Professional & Community Accomplishments

The court also included protection for the family dogs.

**David Gurnick** (Certified Specialist in Franchise & Distribution Law) advised a company in the petroleum industry on compliance with franchise laws applicable to petroleum suppliers and retail gas stations. In a separate matter, David and **Taylor Vernon** represented a prominent travel agency in acquiring the business of an out-of-state travel agency.

**Matthew J. Soroky** was recently retained by an independent filmmaker to advise on negotiations for an option agreement with the film's producers, and to file trademark applications for the underlying work. **Keith T. Zimmet** represented a multi-national corporate client in its purchase of one of Orange County's premiere office buildings. The transaction involved parties located on four continents.

The court granted Nick and Tal's demurrer to all six causes of action with leave to amend. After the time to amend expired, Nick and Tal filed an ex parte motion to dismiss the lawsuit. The court granted the motion and entered judgment in favor of the firm's client.

Both parties have children from prior relationships and intend to keep all assets separate so they can be passed down to their respective children.

In separate matters, Barry and Matt prepared asset purchase documents for the purchaser of a multi-unit tutoring franchise system, and the trademark purchase agreement and assignment for the purchaser of a home care franchise system.

**Veronica R. Woods** worked closely with forensic accountants to reach an equitable division of community property. The parties' estate is valued over \$7.2 million. The opposing counsel accepted our figures as that of the community and separate property estate.

David B. Bobrosky resolved a multi-party car accident for the other driver's policy limits, without having to file a lawsuit. Because the policy limits were not sufficient to fully compensate our client for his injuries, David pursued an underinsured motorist claim against the client's own carrier. Based on a demand letter alone. David was able to obtain the insured's policy limits as well. It is extremely important to uninsured/underinsured motorist coverage in the greatest amounts you can afford. Your own uninsured and underinsured limits should never be lower than your liability limits.

Nicholas Kanter and Hannah Sweiss obtained a favorable early resolution for a local furniture retailer facing an eight plaintiff lawsuit.

David Gurnick and Paralegal Marianne Toghia registered a unit franchise, multi-unit franchise, and area representative franchises for a restaurant chain. Our franchisor client recently granted a unit franchise and its first multi-unit franchise.
