## Biography

Jeffrey A. Kobulnick is a Shareholder in our Intellectual Property and Business Litigation Practice Groups.

With extensive experience in copyright and trademark infringement, trade dress, unfair competition, false advertising, and related claims, Jeff litigates in multiple jurisdictions, including federal and state courts. He also has significant experience handling Internet-related intellectual property issues, such as domain name registration and dispute resolution, and the protection and enforcement of copyrights and trademarks online.

In addition, Jeff extensively counsels and represents clients on brand strategies, including the selection, clearance and registration of trademarks and service marks worldwide.

Jeff earned his Juris Doctor from Franklin Pierce Law Center, where he graduated *magna cum laude*. He was a senior editor of *IDEA: The Journal of Law and Technology*, an active participant in the *Saul Lefkowitz Moot Court Competition*, and served as a judicial extern to the Honorable Dean D. Pregerson in the U.S. District Court, Central District of California. He earned a Bachelor of Science in Animal Physiology and Neuroscience from the University of California at San Diego, where he won the *Ernest C. Mort Award* for outstanding leadership excellence.

*Best Lawyer Magazine* selected Jeff to the *Best Lawyers in America* lists each consecutive year since 2018, in both the Trademark Law, and Litigation – Intellectual Property, categories. In 2020 and 2024, the magazine designated him a *Lawyer of the Year* in Trademark Law. *Super Lawyers Magazine* also named Jeff a *Southern California Super Lawyer* annually since 2014, and he was designated one of Southern California's *Top 100* each year since 2017. Other recognitions include *Who's Who Legal: Trademarks* (2020-21), and an *AV Preeminent* rating by Martindale-Hubbell for legal ability and ethics.
