Alston Bird Land-Use Group Flies to Smaller Firm

DEVELOPMENT: Former area mayor leads move after closure of local office.

ackson DeMarco Tidus & Peckenpaugh has hired four lawyers, essentially absorbing the land-use practice of Alston & Bird LLP, a large Atlanta firm that closed its Ventura County office.

Jackson DeMarco is a Westlake Village firm with 47 attorneys at its headquarters and

an Irvine office. It serves a clientele of developers, land owners and real estate investors.

"The land-use market has been in the doldrums the last few years, but as we come out of the recession we have a number of clients that are reviving old projects, looking for acquisitions or picking up new proj-

ects," said Alim Malik, a shareholder in the firm who recruited the new lawyers. "We have the need to hire competent, well-recognized attorneys to fill the need."

The most high-profile of the new hires is Charles "Chuck" Cohen, former mayor of Thousand Oaks who also served on the city's planning commission. He has experience gaining approval for major projects, including the Village at Newbury Park shopping center and the Rusnak BMW dealership at the Thousand Oaks Auto Mall. In his new job, Cohen will work on project approvals includ-

ing public hearings, entitlements and California Environmental Quality Act compliance. Cohen said Alston & Bird was more interest-

Cohen said Alston & Bird was more interested in corporate finance and litigation, so it madesense for he and his colleagues to move to Jackson DeMarco, where real estate is the focus.

In his new job, Cohen sees more small projects rather than the large developments he worked on in the past.

"The Conejo Valley cities all have general plans that are pretty well built out," he said. "What I see is redevelopment, infill, refreshing of existing industry and retail properties – and probably some conversion of residential to the current apoetite of the marketplace."

Andy Begun, another of the new hires, will specialize in representing builders and lenders under Fannie Mae, Freddie Mac and similar housing loan programs, including bond and low-income housing tax-credit transactions. Carrie Deck will represent commercial real estate lenders and investors in secured financings, loan origination and securitized loan transactions.

Finally, Tom Cohen, son of Chuck Cohen, will provide legal project management for construction projects throughout California. Previously, he led the team that redeveloped the 100-acre former Northrop Grumman site in Thousand Oaks. He chairs the boards at both the United Way of Ventura County and the Alliance for the Arts, the organization that raises funds for the Thousand Oaks Civic Arts Plaza.

Alim said that in addition to Chuck Cohen, the firm has several other attorneys who are former public officials, including Mark Sellers, former city attorney for Thousand Oaks.

"It complements us to bring in public-policy insights to our private clients in how to move a project along," he said.
