Only one percent of licensed attorneys in a given jurisdiction are selected by the ABF Board.

Tal contacted the infringer to demand the immediate removal of the e-book and developed a strategy to get the book removed if no response was received. The infringer removed the book within days.

Jana G. Garrotto and Kyla A. Parrino filed a petition in a matter where a spouse inadvertently left interests in several real properties and deeds of trust in his name. The petition seeks to transfer those interests to the surviving spouse of the family trust.

Vanessa Soto Nellis (Certified Family Law Specialist) protected various investments owned by our client's family with a premarital agreement. The family expressed concerns assets could be used to pay for support or attorneys' fees in the event of a divorce.

Mark J. Phillips (Certified Specialist in Estate Planning, Probate & Trust Law), Zane S. Averbach, and Alex J. Hemmelgarn obtained an expedited resolution regarding an improper property tax re-assessment held by a trust, following the death of the trust's settlor. Despite the backlog of requests at the Assessor's Office, our attorneys represented our client in successfully avoiding years of unnecessary property tax payments. Mark, Zane and Alex also expedited the refund of excess property taxes already paid. Kevin E. Rex, Keith T. Zimmet, Peter L. Ente, and Taylor M. Vernon advised the majority owner of two companies in the cloud computing service industry in connection with the sale of both companies. This multi-million dollar transaction achieved national attention, including in *The Wall Street Journal*, and involved, among other things, complex negotiations with both the buyer as well as with the other co-owners of the companies.

Sue M. Bendavid consulted with a client for months regarding the ongoing needs of a disabled employee. Sue helped our client identify reasonable accommodations and any undue hardships in implementing the accommodations; balanced against the qualifications of the employee. When presented with this analysis, the employee ultimately understood our client's position, and voluntarily resigned.

Barry Kurtz (Certified Specialist in Franchise & Distribution Law), **Taylor M. Vernon**, and **Caitlyn Dillon** were engaged by an outside law firm to help handle due diligence for the purchase of quick service restaurants. The transaction is complex, involving more than 150 restaurants in Central America.

Kira S. Masteller created a life insurance trust for a couple with a taxable estate. The couple purchased second to die life insurance to provide the trustee with cash upon the deaths of both spouses to pay the estate tax without having the life insurance proceeds included in their taxable estate. The estate tax savings for the children will exceed \$2,000,000.

John B. Marshall represented a private nonprofit school to complete a multi-million dollar acquisition of a property adjacent to its existing campus. The complex transaction involved an extended series of negotiations, a lot split of a larger property, evaluation of unusual existing leases, and other due diligence. John also evaluated financing through a combination of taxable and nontaxable loans available to nonprofit entities, and many other complex details. Steven L. Feldman worked with environmental consultants in convincing the state regulator to accept a remedial proposed action plan by our manufacturing client regarding an accidental release of potentially hazardous material. The state's agreement will save our client significant amounts in time and costs.

Jana G. Garrotto and Kyla A. Parrino represent a client who inherited a primary residence from her parent. Under the new regulations per California's *Proposition 19*, Jana and Kyla are coordinating with the Assessor's Office to allow our client to retain the property tax basis of her parent.

Sue M. Bendavid and Gayane Ghandilyan negotiated a settlement of an employee claim – the employee worked for the employer for several years. After standing firm regarding the employer's defenses to the claim, the employee agreed to walk away in exchange for a nuisance value of \$2,000 as severance.

Barry Kurtz and **Matthew J. Soroky** (Certified Specialists in Franchise & Distribution Law) are working with a franchisee who believes its franchise was wrongfully terminated by the franchisor. In a different matter, Barry and Matt represent a client who wants to exit the franchise system because of continuing annual losses.

In a separate matter, Steve also finalized a lease addendum for another manufacturing site which significantly broadened the client's authorized use of the premises.

Sue M. Bendavid represented a client investigating discrimination and whistleblower claims by a former employee. Sue worked with the client to assess all allegations and document the results of the investigation.

Matthew J. Soroky and **Jeffrey A. Kobulnick** successfully defended a franchisor client facing various fraud and unfair practices claims brought by a franchisee in federal court, by persuading the court that the claims should be dismissed without leave to amend because they were preempted by the *California Franchise Investment Law* and barred by a statute of limitations. The case has been amicably resolved. **Barry Kurtz** and **Katherine L. Wallman** (Certified Specialists in Franchise & Distribution Law) represent two, separate clients looking to franchise in Australia and Hong Kong, respectively. Our attorneys are reviewing and preparing letters of intent and franchise documents for each client. In separate matters, Barry and Kate are working on initial franchise registration for a pet care business; and reviewing franchise disclosure documents for a client buying a restaurant franchise.

Jeffrey A. Kobulnick and Taylor M. Vernon sent cease and desist letters to two different companies using a client's federally registered trademark for similar services. Both parties complied with our demands to stop using the client's mark, and also paid money to the client. For another client in the cosmetic eyecare industry, Jeff obtained federal trademark registrations for several forms of trade dress after the client had been advised by other attorneys that such protection could not be obtained.

Steven L. Feldman settled a contentious and highly litigated civil partition action, which included a multi-million dollar cash buy-out of our client's interest for 2.5 times the amount of the original offer.
